Quick Winter Weather Reminders...



### **Snow Events -**

The Grounds Committee and LOB Board monitor all weather events and are in frequent communication with LandArt prior to, during and immediately after any snow or ice event. LOB's contract for snow removal calls for removal to begin at 2". Shovels and snowblowers are normally used on driveways, sidewalks (both main and up to front stoops/porches) and mailbox pads and snow plows on streets and parking pads. Salt is spread on any needed areas. We encourage all residents to refrain from parking on streets and driveways during a snow event to allow for better removal and avoid any damage.

### **Holiday Decorations –**

Winter holiday decorations are permitted in the front mulched planting areas and on porches and rear decks and must be removed once the season is over. Refer to page 7 under Items Not Permitted..., item 3 for details. Please keep in mind that any cords should not be run over sidewalks or driveways, as snow removers cannot be responsible for running over them and they could pose a trip hazard for visitors. While we like to see lights out, we also don't encourage any roof displays!!

#### Tennis Net & Clubhouse/Restroom Use -

The net has been removed and stored for the winter, the court gate and the exterior entrances to both restroom doors have been locked. That means the only restroom available for use is the Men's restroom and the only way to access it is through the main clubhouse door. Please DO NOT unlock the exterior door to exit the restroom.

### Fall Leaf Pick-up -

Unfortunately, Mother Nature took a quick turn of events on the calendar. LandArt was scheduled to complete the final leaf pick-up the week of December 1. This would have also included placing snow stakes throughout LOB. WELL...it was a nice plan! At this point, any leaf pick-up will have to be rescheduled, weather permitting.

#### 2026 Dues Assessments -

At the October Annual Meeting, as part of the 2026 budget approval process, our quarterly dues assessment was raised to \$700 per quarter (an increase of \$25 per quarter). This increase was approved with a vote of 53 units voting in favor/15 opposed. TNG will be sending Q1 statements out in early December that will include instructions on payment processing.
